If the traffic is received by the MNA from a connecting carrier, the consignee located on the MNA will pay the freight.

If the traffic is delivered to a connecting carrier from the MNA, the consignor located on the MNA will pay the freight. Rate applies to traffic interchanged with the BNSF or KCS Railroads.

Rate is contingent on whether the subject traffic moves less than or greater than 500 <u>highway miles</u>. The mileage criteria applies to the entire route, beginning at the initial point of origin and ending at the final destination (this includes points to/from beyond the MNA). Highway mileage will be sourced from Rand McNally data.
